Interest Calculations and Tiers

- A: Calculated daily on the whole balance based on the rate applicable for the balance tier and paid monthly on the last day of the month unless otherwise stated.
- B: Calculated daily on the portion of the balance which falls within each of the tiers and paid monthly on the last day of the month unless otherwise stated.
- C: Calculated daily on whole balances. Bonus rate applies where the balance has been retained and at least one processed deposit of \$1.00 or more has been made with no withdrawals during the month, otherwise the Standard Rate applies. Noting that as a result of end of month processing requirements, transactions received after 12 pm (AEST) on the last day of the month may be processed the following day impacting bonus interest eligibility.

- *** To be eligible for this account you must be a pensioner or a self funded retiree.
- ++ A savings account available to members aged 12 to under 18 years of age. Account is also available to members under 12 years of age, where the membership is held in the parent or guardian name in trust for the young member. - Interest on overdrawn accounts is calculated daily on the closing balance. Our current overdrawn rate of interest is 14.46% p.a.

Retail deposits only. Amounts of \$1,000,000 or more are by acceptance and rates will be negotiated.
